Message From Your Association President

Joe Bowen, Apache Red

Gentlemen: I apologize for remaining quiet for too long and letting misinformation spread by a few begin to tarnish OUR great Association. I can take the heat but have realized that my doing so may have had a negative impact upon OUR Association. A few of our members have over the months set up an “us against them” atmosphere and have cast aspersions upon myself and some of your other devoted members on the Board of Directors.

Unfortunately there are those among us who, if their personal desires are not fully addressed, start whisper campaigns against and about others. These same individuals appear to be interested in their own wants and desires and hold the wants, desires and needs of the Association as secondary to their own.

I and other Board members have been attacked by phone and the favorite frag of the internet - e-mail. Claims are easy to make - they just take words. Facts are a lot harder to come by. A number of you have expressed anger at the disrespect that has been directed at me and at the Association Board of Directors. Your anger is well placed and your expressions of support are appreciated. But it is the disrespect and disregard shown for, or directed at, the full membership that is of greater concern and which you should keep fresh in your minds.

So let us get the facts straight. I will briefly discuss what I believe are two of the major issues that have been ripping the airwaves and the email frags. If anyone wants to talk to me about these issues face-to-face or on the phone I welcome the chance – none of the disgruntled have wanted to do so or have had the time. If you do not want to hear about these things skip to the next page after the Crossed Sabers picture to *HEADHUNTERS IN IRAQ*.

The Motts Military Museum Monument. *Up front -The monument is a great tribute to the Squadron.*

- (1) Some association members made arrangements to have a monument erected at the Mott's Military Museum
 - (2) They let people know in advance they were doing it, but never requested funding approval from the membership or the Board, and some wanted the new Board to pay for part of the monument costs.
 - (3) On 21 April 2007 Al Tyre presented to all the Board members details on the 9th Cavalry Monument Fund and requests for funding after the fact. The Board voted unanimously NOT to use association money for this purpose for three reasons:
 - A. The official Bullwhip Squadron memorial was placed at Fort Rucker in 2003. The BWS monument proposal for FT Rucker was presented to the members and approved by the Board before any contract or monies were committed. After approval and pricing the process began to include the agreement with the US Army to locate the monument on government property
 - B. The Motts Military Museum is a privately owned museum.
 - C. Funding a project without prior coordination and approval for association funds by the membership and the Board would set a unfavorable precedent that could place future Boards in financial debt not planned.
- The 9th Cavalry Monument Fund is a worthy effort and anyone can contribute to fund. For those who seem to have forgotten they will find in the 3rd and 4th Quarter 2007 newsletters two separate full page articles about the monument with fund contact info.

Vacant Vice President Position As prescribed in our Bylaws if any office of the Corporation which becomes vacant prior to expiration of the normal term thereof for any reason, including resignation, removal, disqualification or death, may be filled by the Board of Directors for the unexpired portion of such normal term. Al Tyre resigned and when it became apparent that he would not consider a possible return to the association the Board nominated and voted unanimously to appoint Jim Kurtz as the new Vice President. For those who are still throwing rocks they were very quiet back then and I do not recall any of them offering to serve the association. Jim is contributing to Bullwhip and he is a great addition to the Board!

Message From Your Association President

The Bullwhip Website Back in 2000 I volunteered to set up the initial Bullwhip website. After a time my increasing job activities made it impossible to properly keep the website up to date and growing. The Board of Directors found another volunteer, Loretta Sager (CAV GIRL) to take over management of the site. I worked with her to transfer over the technical details, the pictures, graphics and information to enable her to begin updating the site, and we were able to see our association be better represented on the World Wide Web. Loretta did a remarkable service for us all and she began to expand our site with newer and better interactive items than we had before. However, there began a noticeable decline in updating and posting of new material the Bullwhip site and we understood there were various reasons for those changes. The membership was gracious about the declining state of the site and at the 2006 Reunion even collected a substantial number of donations to send to Loretta. After I took office I called Loretta (13 January 2007) and discussed the site with her and promised that the board would provide her with resources to upgrade the site and improve response to our membership. I asked her to provide us with a list of the top ten things she needed to bring the association website to a higher quality and provide higher speed/access for pictures and video. The items discussed were additional webmaster and/or website design help, updated software and hardware (scanner, printer), phone cards, mailing and printing funds, and new domain/web server. In addition, I asked her about original pictures, slides and movies that members had sent to her for duplication. I told her that she could send them to us (COD or prepaid by Bullwhip) and we would have the duplication done instead of her having to take the extensive time required as she had commented on to do this type of effort. At every board meeting the situation was discussed and each time we agreed to let Loretta continue in the hope she would work together with us to go forward. Finally, in November 2007 the board agreed to change the Bullwhip website to better support our membership and be more responsive to information requests from members. The first response we got from Loretta on 5 November 2007 was a threat to take legal action against us for using a graphic that she claimed was unique. We responded that same day, asking her to specify the particular graphic she was referring to and we would immediately correct *any specific* item that she declared was incorrect on the new site. Loretta did NOT respond - so we moved on. Your board of directors has devoted a lot of effort to enhancing your website but it does require Troopers to contribute information to build it into a site that all of us can use. Members' comments and recommendations are and have been implemented to enhance the experience - and we realize that much more needs to be implemented within the site. Take a look at the Bullwhip site today and if you have comments and /or recommendations let us know.

SQUADRON MEDAL OF HONOR AWARDEES' PRINTS Next year will mark 40 years since we lost two of our brothers that were awarded the Medal of Honor Posthumously . On 2 June 1969 1LT Bob Poxon, Saber Blue died protecting his Blues on LZ Phyllis. On 14 September 1969 SGT Donal Skidgel was killed during a convoy ambush near Song Be while protecting his Delta Troop bothers . On 26 February 2011 it will be 40 years since another B Trooper, CPT Jon Swanson, gave his life engaging the enemy while flying his LOH in Cambodia. I would like to open discussions with the association members on the possibility of teaming with another organization and an artist to have a series of three prints made to commemorate their valor. We would select a committee to research the required actions, possible funding avenues (including private and commercial donations) and distributions of the prints. Of course we would coordinate with any surviving family members and Troopers that were witnesses to ensure that the prints were accurate and done with good taste and respect. We would see if it is feasible then contact the surviving family members before continuing. Comments and feedback are welcomed.





Subject: Major Weeks

I just saw where Major Weeks has passed away. I want to extend my deepest condolence to his family. I was with the Blues and remember him as one of the great leaders of the squadron I served under. Never talked to him much just the time when the blues had to get a huey that was shot down on a mountain, in the Ashau valley.

We took with us chain saws to clear the area. No problem getting off, it just looked like the blades were going to hit the side of the mountain, but somehow they didn't, we had some heck of a pilots. Don't remember exactly but I think we couldn't wait to get it lifted because the scout ships had spotted a large group of NVAs moving fast toward our position.

As the first chopper came to extract us it couldn't lift off and the blues that managed to get on had to bail off before it crashed. It was now impossible to get us out because the choppers just couldn't get enough RPMs to lift off. We were too high up and the air was too thin. The Major wasn't going to leave us, there wasn't enough time for reinforcements or to take an alternate route. So he ordered us to leave behind any extra weight, just to take our weapons and to jump on or hang on to the skids as he would fly by and drop off the edge of the mountain with some of us hanging on to the skids. It was unbelievable as it went down before it had enough RPMs to lift up, it was impossible but he got us out. It was great falling off a mountain hanging onto the skids of a chopper, and trying to get back on in mid-air. Anyways it's how I remember it. Later he explained and showed me how they were trained on free falling. I remember sitting behind him as he turned everything from the chopper off and told me to tell him when to turn it back on. I said OK no problem but after just dropping for few seconds I urgently told him to turn everything back on, he just smiled and let it go for a few more seconds then turned it back on, it was a heck of a ride. This is what I remember of one of his many missions and I know he had many close calls, this was like no big deal to him, to me it was, he saved all of us that day, he was a Hero.

We shook our heads in confusion as to why John B. Stockton was not in the Hall of Fame and I told him we should continue the effort. As we all know and as many Army Aviation Association of America Directors well know LTC John B. Stockton, our BULLWHIP 6, was instrumental in developing the our Army's Air Cavalry concept.

I have included Dave's September 2003 newsletter entry to refresh our memories on some of the past frustration and to help reengage the efforts to enable BULLWHIP 6 to be properly recognized by Army Aviation. We will endeavor to combine our resources to present AAAA a revised nomination packet for the upcoming Hall of Fame process. We request your support in this deserving endeavor and will keep you



Call to Arms *(From the September 2003 newsletter)*

The BWS Association needs your support on a very important effort. It concerns the nomination of our first commander John B. Stockton to the Army Aviation Hall of Fame. First of all, a little background on this effort. Several months after Col. Stockton's death, I took it upon myself to put together the required paperwork and submitted it to the AAAA office in June of 1998. The Board of Directors, along with several previously inductee Hall of Famer's then select 8 to 10 individuals for nomination and publish their names with a short bio in the July – August 1998 AAAA magazine, for the members to vote upon.

Prior to the publication of those selected individuals, I was called by a very respected retired Major General who had been a member of the selection committee and this is what he told me: "Dave, I appreciate your effort in submitting Col Stockton's name for consideration as a Hall of Fame inductee. I personally supported his nomination but there was to many old dinosaurs on the selection board that do not like John B. for various reasons, and they turned his nomination down. I recommend that you wait 5 or 6 years until some of those dinosaurs pass on and then try again."

Now, we skip ahead to 2003. I asked Loel Ewart in May to put together another submission under his name. With input from Joel Steine and Mike Bogdue, Loel put together an excellent paper submitting John B. for consideration as a candidate to the Hall of Fame. The paperwork was forwarded to the AAAA editor in mid June.

What can our BWS members do to make John B.'s selection a possibility? First of all, he must be approved by the selection committee for nomination by AAAA members, sometime within the next few months if not sooner. The only hope that we have is that the few remaining old dinosaur's will be outvoted and John B's name will be published in this fall's AAAA magazine, along with the other candidates for membership vote.

If we are successful in that effort, all BWS members of AAAA can assist by "talking up" his nomination with other AAAA members. If you aren't a member of AAAA, consider joining for 1 year for the sole purpose of voting for John B.

This will probably be our last chance to get him into the Hall of Fame. As the creator of the Air Cavalry concept, he richly deserves this honor. I therefore request your support in this endeavor.


A TROOP NEWS

CW5 Charles A. Adkinson (Apache 34, 69-70) retired from the Ohio Army National Guard on his 60th birthday, March 24, 2008, concluding a 40+ year career. Adkinson enlisted in the U.S. Army on December 14, 1967 and transferred to the Ohio Army NG in 1971. His career included a Vietnam deployment in 1969-70 and a Middle East/Operation Iraqi Freedom deployment in 2006-07. As an Army pilot flying combat missions during these deployments, Adkinson flew helicopters with A Troop 1/9th Cav, 1st Cavalry Division in Vietnam and airplanes with the 1-111th GSAB, U.S. 3rd Army in the Middle East. While based in the Middle East, Adkinson was the 3rd Army's C-12 Detachment Commander. He retired as a Chief Warrant Officer 5 and Master Army Aviator and his career spanned the terms of 8 Presidents and all/parts of five decades. CW5 (ret) Adkinson graduated from Dayton Chaminade H.S. in 1966, attended Ohio State University and is a 1994 graduate of Capital University in Columbus, Ohio. He and his wife Susan live in Marysville, Ohio.


